Motion: A motion was made by Chris Woolverton and seconded by Pam Freeman to approve the Expenditures and Encumbrances for the month of October 2012. The motion passed.

Commissioner's Report

Section 521.08 Addendum of the Solid Waste Code was approved by council and the first fine has been issued for failure to remove trash from the property on University Drive.

Jeff stated that he had met with the Zoning Dept. to discuss unlicensed rental house concerns. The Health Department has been seeing an increase in complaints from unlicensed rental homes as well as running into many unlicensed rental homes in areas that are zoned for single family only. We will continue to meet with Zoning and Community Development to develop a recommendation to council on how to deal with these issues in the future.

Jeff stated that he will be breaking down the immunization clinic numbers as well as TownHall II treatments and services that the Health Department is paying for.

The food planning guide has been updated and has been made available in the Board packet for review. The last food safety planning guide needed some significant updating. The new guide is about 10 pages longer than the previous one and covers additional items such as adequate hot water supply measurements and kitchen equipment floor plans.

Four (4) individuals in Kent received the injectable steroids that have been implicated in the multistate outbreak of fungal meningitis. So far there have been no signs/symptoms with the patients but they are being monitored closely by their doctors and the Portage County Nursing staff.

The Health Department is in the process of developing a Food Safety Training Course to be offered in the first quarter of next year. Through this past year it has become evident that the "Person in Charge" of the food service operation is not always knowledgeable on safe food handling practices or procedures. We have sent materials we plan to use to the Ohio Dept. of Health for their review which is a requirement before offering a class such as this one. We also plan on offering CEU's for Sanitarians in the area who may be interested. If approved we will charge a small fee for the course as we plan on having take-home workbooks and materials for attendees to refer to. Our initial plan is to offer the courses bi-monthly in the beginning and then go to a quarterly

basis. The course will be a mixture of lecture and demonstrations. It will last approximately 2 hours. It will be held in the Kent City Council chambers. The Powerpoint presentation and Glo Germ Demonstrations was included in the Health Board information sent out last week. We are also working with the Ohio Department of Agriculture to conduct Cottage Food Industry training for the Haymaker's Farmers Market Vendors this winter and spring.

The KSU Smoking Committee has developed a survey for students and faculty to respond to. They have until the 26th and the results will be shared once completed.

The EH DSI is continuing to progress quickly and we have submitted the number of licenses needed by our department to ODH so we can start using the program once it goes live.

The monthly preparedness report from Portage County was included in the health board packet for review.

The NALBOH Newsbrief is now available.

Old Business

Medical Director's Contract: Anthony Bartholomew, D.O. had an opportunity to comment and change the contract. His suggestions/revisions are in red. Chris Woolverton stated that there will be a time where someone interested in the position will emerge again and request a copy of the current and/or previous contract, and there are items that need to be changed to reflect our communities needs and the Health Departments needs. These changes will be reflected in future contracts.

Motion: A motion was made by Susan Roxburgh and seconded by Marchelle Bobbs to keep the contract the same as last year and request Dr. Bartholomew to sign it. The motion passed.

New Business

Akron Regional Air Quality Management District (ARAQMD) Contract

Motion: A motion was made by Chris Woolverton and seconded by Pam Freeman to modify the current contract or enter into a new contract with ARAQMD, to allow them to bill local industries for air quality monitoring. The motion passed.

Food Service Cost Analysis Completed & Fee Increases

Operating costs in the current food service and retail programs for the year exceeded money collected from fees by \$6,242. We lost \$130 from mobiles, \$475 from vending and \$2,600 from temporary operations. The food program fees and operating costs should balance.

Motion: A motion was made Pam Freeman and seconded by Susan Roxburgh to approve the first reading, to raise food service fees to cover operating costs. The motion passed by roll call vote: Chris Woolverton, Aye; Pam Freeman, Aye; Susan Roxburgh, Aye; Marchelle Bobbs, Aye; Doug Wagener, Aye.

The Health Department needs the Boards approval on our new Embargo Policy. According to the Ohio Revised Code, food shall be embargoed whenever a licensor finds a retail food establishment or food service operation with any perishable foods that are unsound or contain any filthy decomposed or putrid substance(s), or that may be poisonous or deleterious to health. The licensor shall destroy the foods or render the items unsalable as human food.

Motion: A motion was made by Chris Woolverton and seconded by Pam Freeman to approve the Embargo and/or Discarding guidelines for Potentially Hazardous foods in Retail Establishments and Food Service Operations. The motion passed.

Health Department staff have developed new guidelines for Retail Food Establishment Process Review Inspections which need the Board's approval.

Motion: A motion was made by Pam Freeman and seconded by Chris Woolverton to approve the Retail Food Establishment Process Review Inspection Guidelines. The motion passed.

Health Department staff have developed new guidelines for Mobile Food License Requirements which need the Board's approval.

Motion: A motion was made by Susan Roxburgh and seconded by Marchelle Bobbs to approve the Mobile Food License Requirements and checklist. The motion passed.

All local Health Departments need to have a list of Critical Violations and Control Points from Ohio Uniform Food Safety Code. Our list is established and requires the Board's approval.


Motion: A motion was made by Chris Woolverton and seconded by Pam Freeman to approve the list of critical violations in Food Safety as supplied by the Health Commissioner. The motion passed.

Standard Operating procedures for handling solid waste complaints have been established and require the Board's approval.

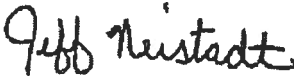

NEW BUSINESS:

CASE NO: PC12-005
APPLICANT: Fairmount Properties – Building C
SITE LOCATION: 210 South Depeyster Street
STATUS OF APPLICANT: The applicant is leasing the property from the City.
REQUESTED ACTION: Site Plan Review and Approval for multiuse
ZONING: C-D: Commercial Downtown
TRAFFIC: The site is accessed from East Erie Street, Locke Lane and South Depeyster Street.
SURROUNDING LAND USES: The property is surrounded by commercial uses.
APPLICABLE CODE SECTIONS: Chapter 1113 and 1146 of the Kent Codified Ordinances.

ANALYSIS:

PROJECT DESCRIPTION:

Fairmount Properties LLC is proposing mixed use building at the southwest corner of East Erie Street and South Depeyster Street. The first floor will consist mostly of a restaurant with a small vestibule and another space yet to be determined but perhaps a fitness room to service the upper floors. The upper four floors will be residential consisting of 4 - one bedroom and 4 - two bedroom apartments per floor for a total of 48 bedrooms.

TRAFFIC/PARKING:

The proposed parking plan for this building is to utilize the multimodal facility for the residential needs and restaurant parking including valet parking and other public parking area for the restaurant use such as the new parking lot off Locke Lane (Alley No. 5) which is available after 6 pm.

UTILITIES:

The adjacent roadways provide access to all utilities.

STORMWATER:

A storm water management system for quantity will not be required at this site. Storm water quality measures will be provided most likely through a vegetated swale.

SIGNAGE:

Proposed signage will match the existing signage for Buildings A & B.

LIGHTING/LANDSCAPING/DUMPSTER:

A green space with vegetation is proposed in the southwest corner of the lot. The dumpster is shown on the plans with an enclosure along Locke Lane.

ARCHITECTURAL ADVISORY BOARD:

The Architectural Advisory Board approved a Certificate of Appropriateness on December 4, 2012.

VARIANCES:

Several zoning code variances will need to be presented to the Board of Zoning Appeals. The property has three frontages (East Erie Street, South Depeyster Street and Locke Lane.)

1. KCO section 1146.05(b) which has a limit of 60' for the height. The building is slightly higher measuring 60'-4" at Erie Street, and 62'-3" along Depeyster Street.
2. KCO section 1146.05(c) which requires 70% of the frontage to be occupied by the building.
3. KCO section 1146.04(a) which requires the building face to be on the building line (property line).

RECOMMENDATION:

Staff is recommending that the Planning Commission approve the site plan with the condition listed below.

Planning Commission may approve, approve with conditions, or disapprove the application. Should Planning Commission wish to approve this project, the following language may be used:

I move that in Case PC12-005, the Planning Commission approve the Site Plan to construct a mixed use building at 210 South Depeyster Street subject to the following:

1. Technical Plan Review.
2. Granting of variance(s) from the Board of Zoning Appeals (BZA).

APPLICANT: Art & Heart Gallery

SITE LOCATION: 707 South Water Street

STATUS OF APPLICANT: The applicant is leasing the property.

REQUESTED ACTION: Conditional Zoning Certificate and Site Plan Review and Approval for a tattoo/body piercing business and art gallery

ZONING: R-C: High Density Multifamily – Commercial

TRAFFIC: The site is accessed from South Water Street and East Hall Street.

SURROUNDING LAND USES: The property is surrounded by commercial uses on the south & west sides and residential on the north and east sides.

APPLICABLE CODE SECTIONS: Chapter 1113 and 1137 of the Kent Codified Ordinances

ANALYSIS:

PROJECT DESCRIPTION:
The applicant is proposing a tattoo and body piercing business. Customers will have to make an appointment to have the work performed. Initially the business will have three employees with a potential for six. The business will be open from 3 pm to midnight. The applicant is also proposing to display/sell artwork.

TRAFFIC/PARKING:
Six spaces are required by the code and eight spaces are shown on the plan. The City is going to require the spaces be re-striped so that the vehicles do not back out over the curb onto South Water Street. There is also a question as to whether the parking spaces off of East Hall Street are adequately sized. The parking layout will need to be adjusted. There is on-street parking available on the north side of East Hall Street.

UTILITIES:
Utilities are existing.

STORMWATER:
Storm water management is not required since this is an existing site.

SIGNAGE:
The applicant will be re-facing the existing pole sign.

LIGHTING/LANDSCAPING/DUMPSTER:

No additional lighting or landscaping is proposed. The applicant plans to use trash cans, not a dumpster.

ARCHITECTURAL ADVISORY BOARD:

The Architectural Advisory Board did not review this project since it is an existing building.

VARIANCES:

No variances are required.

RECOMMENDATION:

Planning Commission may approve, approve with conditions, or disapprove the application.

Should Planning Commission wish to approve this project, the following language may be used:

I move that in Case PC12-028, the Planning Commission approve the Conditional Zoning Certificate and Site Plan to operate a tattoo and body piercing business at 707 South Water Street subject to the following:

1. Technical Plan Review.
2. An acceptable modification of the parking layout.

Comprehensive sign package for a Hotel and Conference Center

ZONING:

C-D: Commercial - Downtown

TRAFFIC:

The site is accessed from East Erie Street and South Depeyster Street

SURROUNDING LAND USES:

The property is surrounded by residential to the southeast (across Haymaker Parkway) PARTA's multimodal facility to the north, commercial to the west

APPLICABLE CODE SECTIONS: Chapter 1165 of the Kent Codified Ordinance.

ANALYSIS:

PROJECT DESCRIPTION:

The owner of the building at 230 East Erie Street, Pizzuti Companies, is constructing a hotel and conference center. The applicant is requesting approval of a comprehensive sign package since the number and size of the signs exceed that allowed by the zoning code.

The comprehensive sign plan purpose and standards are listed below.

Purpose - A Comprehensive Sign Plan is intended to integrate the design of the signs proposed for a development project with the design of the structures, into a unified architectural statement. A Comprehensive Sign Plan provides a means for defining common sign regulations for multi-tenant projects, to encourage maximum incentive and latitude in the design and display of multiple signs and to achieve, not circumvent, the intent of this Chapter.

Standards - A Comprehensive Sign Plan shall comply with the following standards:

- (1) The Planning Commission may allow signage which otherwise exceeds the number, type, size and placement as otherwise permitted in this Chapter when it determines that such additional signage is warranted due to the size, nature, number of tenants or other features of the site as they may exist.
- (2) The signs shall enhance the overall development, be in harmony with, and relate visually to other signs included in the comprehensive sign plan, to the structures and/or developments they identify, and to surrounding development;
- (3) The Plan shall accommodate future revisions that may be required because of changes in use or tenants; and
- (4) That the Plan is consistent with the Design Guidelines that may be applicable to a designated area as may be identified in Chapter 1121 of the Kent City Zoning Code. In areas of the City not governed by the Design Guidelines identified in Chapter 1121, the Plan, to the degree feasible, shall comply with the recommended Sign Design Guidelines set forth in Appendix B of the Zoning Code.

ARCHITECTURAL ADVISORY BOARD:

Architectural Advisory Board had several conditions attached to the Certificate of Appropriateness. These conditions have all been addressed in this submittal. A Certificate of Appropriateness was issued on December 4, 2012.

VARIANCES:

Should the Planning Commission approve the comprehensive sign plan, variances from the Board of Zoning Appeals would not be required.

RECOMMENDATION:

Staff is recommending approval with the conditions listed below.

The Planning Commission may approve, approve with conditions, or disapprove the application. Should Planning Commission wish to approve this project, the following language may be used:

I move that in Case PC12-029 Planning Commission approve the Comprehensive Sign Plan for the hotel and conference center at 230 East Erie Street and 215 South Depeyster Street subject to the following conditions:

1. Obtain a zoning permit within two years of Planning Commission approval.
2. Obtain a sign permit and submit the performance guarantee prior to installation of the signs.

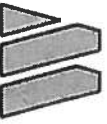

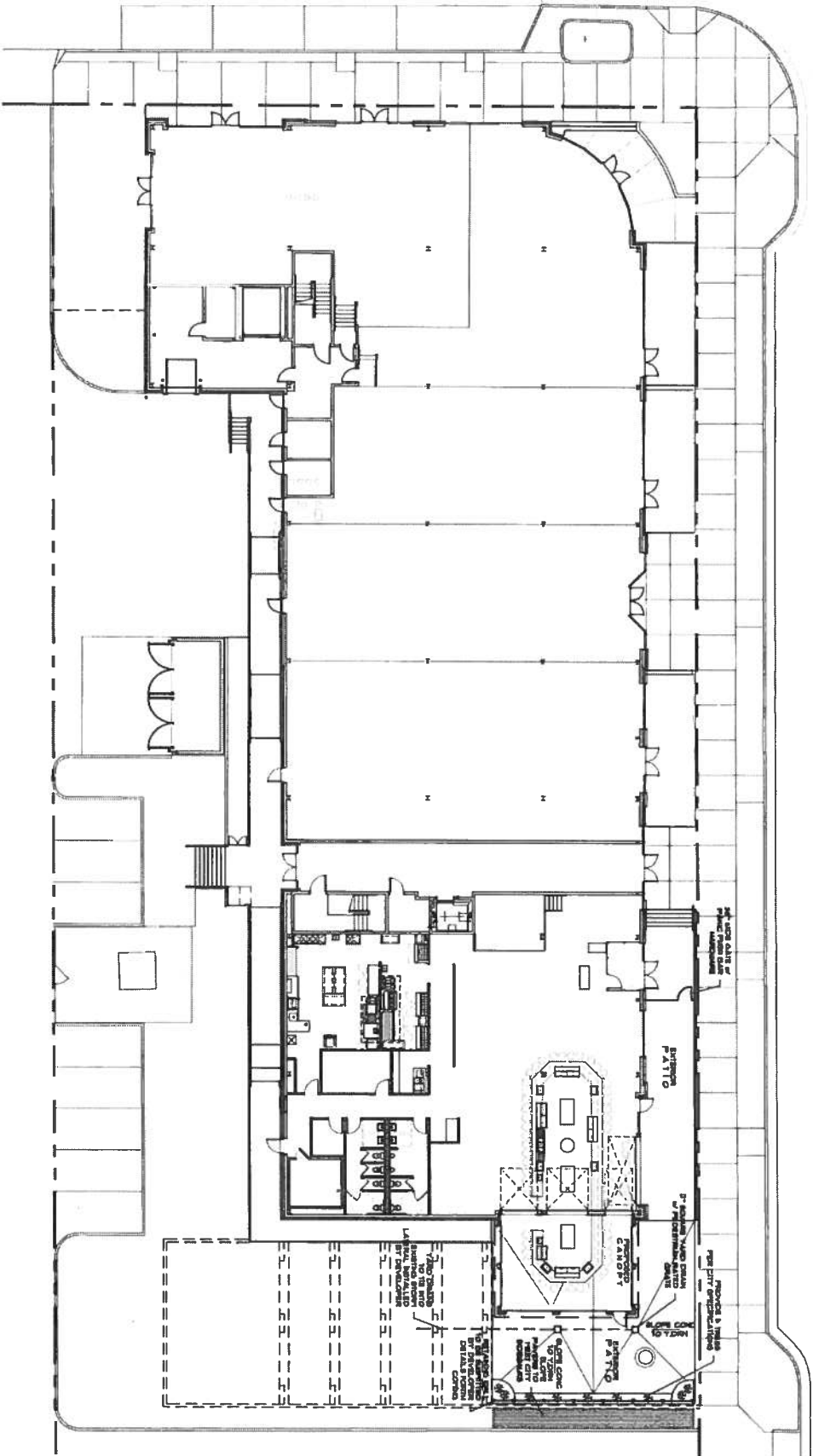
